a message from the

EXECUTIVE DIRECTOR

The Vermont Children's Alliance (VCA) has had a busy and exciting year in 2022. When change and uncertainty felt like the norm, VCA has remained consistent and strong in its mission to provide support for Child Advocacy Centers (CACs) and Multidisciplinary Teams by continuing to offer education, training, consultation, and support across Vermont.

In 2022, the VCA again went through the comprehensive reaccreditation process through the National Children's Alliance (NCA) and had our site visit in November. Reaccreditation with NCA happens every five years, and Accredited Chapter membership of NCA requires compliance with the following Accreditation Standards: Organizational Capacity; Membership; Growth and Development; Training and Technical Assistance; and Awareness and Education.

VCA was able to strengthen our organizational capacity by securing additional funding to increase staffing to provide stronger prevention and programming. We have added a part-time Community Education and Outreach Coordinator to focus on building awareness of child abuse and the role of the CACs throughout Vermont. Additionally, a part-time Training and Special Projects Coordinator was hired to further expand the VCAs continued efforts to provide education and high-quality training to multidisciplinary team members. Through this growth, the VCA and its membership can support more of Vermont's children affected by child abuse by supporting child abuse professionals in Vermont.

We brought Basic as well as Extended Interview Training to Vermont and continued to contract with a specialist to offer statewide Forensic Interview Peer Review. Additionally, we teamed up with Zero Abuse Project and offered LGBTQIA+ Children in the Forensic Interview training to our statewide partners on top of supporting attendance at various training and conferences like the International Symposium on Child Abuse, Crimes Against Children, and International Forensic Nurse Conference.



WHAT WE DO

The Vermont Children's Alliance (VCA) is a non-profit network of child advocacy centers committed to working together to improve the way Vermont supports and resp<mark>onds to</mark> victims of child abuse and child sexual abuse. Our 13-member organization serves all 14 counties in Vermont.

Our goal is to provide every child victim in the state of Vermont, along with their non-offending caregivers, with a friendly and safe space where allegations of child sexual and physical abuse can be investigated while appropriate supporting resources and services are being provided.

At a CAC, a coordinated team of experts in health and human services, law enforcement, victim advocacy, mental health, and other disciplines holds offenders accountable and helps children and families heal in a comprehensive, seamless way. This team of experts is called a multidisciplinary team or MDT.


2022 SNAPSHOT

TRAINING

In 2022, the Vermont Children's Alliance provided or supported specialized training for over 200 professionals. These trainings included Basic Forensic Interview training; CAC Management Training; Extended Forensic Interview training; Physical Abuse training; Forensic Interview Peer Review and Forensic Nurse Sexual Assault Training as well as others. Additionally, the Vermont Children's Alliance supported attendance at the Crimes Against Children Conference, the National Children's Alliance Leadership Conference, the International Symposium on Child Abuse, and Hope Changes Everything


TECHNICAL ASSISTANCE

VCA provided administrative support in helping our 13 member programs to meet the National Children's Alliance standards for accreditation.
Additionally, we distributed over \$22,000 in equipment and technology directly to our CACs, including forensic interview equipment, digital intelligence equipment and statewide video conferencing. We facilitated 6 bi-monthly membership meetings and on the off months, held full board meetings with our membership



CHILD ADVOCACY CENTER

At a Child Advocacy Center, or CAC, a coordinated team of experts (multidisciniplinary team or MDT) in health and human services, law enforcement, victim advocacy, mental health, and other disciplines holds offenders accountable and helps children and families heal in a comprehensive; seamless way: The child meets once with a trained interviewer who knows the right questions to ask.

Then, based on the interview, the MDT makes decisions together about how to help the child. Finally, CACs offer a wide range of services like therapy, medical exams, courtroom preparation, victim advocacy, case management, and others to help produce better outcomes.

To really understand what a CAC is, you must understand what children face without one. Without a CAC, the child may end up having to tell the worst story of his or her life over and over again, to doctors, law enforcement, lawyers, therapists, investigators, judges, and others. They may have to talk about that traumatic experience in a police station where they think they might be in trouble, or may be asked the wrong questions by a well-meaning teacher or other adult that could hurt the case against the abuser.

National Children's Alliance Membership Status







LOOKING AHEAD

Looking ahead to 2023, we expect the Chapter to be reaccredited by the National Children's Alliance for another five years. Additionally, 11 of the 13 child advocacy centers in Vermont are accredited, and both of the remaining Associate members submitted their accreditation application to NCA. We are on track to have all 13 CACs accredited in 2023.

We are proud of our CAC and multidisciplinary team members in continuing to provide a dedicated response to child abuse across the state of Vermont. Our member centers are providing services to hundreds of children each year and more recently have noticed an increase in more involved critical incidents of child abuse than seen in previous years.

Our collective professional dedication to mitigating these traumatic events through the constellation of services provided at each CAC across the state remains constant. The support VCA provides to the professionals working with CACs statewide is more important than ever before.

It is our intention to continue to support the development and growth of the CACs across our state as well as promote system improvements for children and families affected by child abuse. We will identify and coordinate more funding opportunities, expand professional networking and peer support opportunities, and promote the growth and continuation of the multi-disciplinary team approach to intervention in child abuse cases.
